



Legacy Scholarship

The Legacy scholarship is offered to Bethany International staff and missionaries.

The Legacy Scholarship (US Citizens)

This scholarship covers the costs of Room and Board. This leaves qualifying US students with the out-of-pocket cost of standard and additional fees each semester.

The Legacy Scholarship (Internationals)

This scholarship covers the costs of Room and Board and the remaining Tuition costs. This leaves qualifying international students with the out-of-pocket cost of standard and additional fees each semester.

Fee payments must be made by the deadline date each semester or start of the school year.

Practical Training Tuition Scholarship or Federal Work College Award (FWC)

All students take part in a [Practical Training](#) assignment in a department on campus. Students who successfully meet the requirements of Practical Training receive a scholarship. By the end of the school year, this scholarship covers more than half of the student's annual tuition costs before the Legacy Scholarship is applied.

Tuition-Paid Model (US Citizens)

Though the tuition paid model is optional for BGU students, any US student wishing to receive the Legacy Scholarship must complete the steps required to qualify for the tuition paid model:

Pell Grant

All eligible students who choose to receive the tuition-paid benefits are required to apply annually for Federal Student Aid by completing the FAFSA online. Federal Pell Grants are applied to the cost of tuition.

BGU Student Aid

After the Practical Training Tuition Scholarship/FWC and Pell Grant are applied to tuition costs, the remaining cost of tuition is fully covered by the BGU Student Aid Scholarship. If you qualify for federal student loans or private loans, they may cover all or part of the costs of room, board and required annual fees.

The following page includes the estimated breakdown of the Freshman year costs which remain after the Legacy Scholarship has been applied.
